## Minutes of the Regular Meeting Potrero Hill Democratic Club Held September 1, 2015

The regular meeting of the Potrero Hill Democratic Club (the "<u>Club</u>") was held at the Potrero Hill Neighborhood House on September 1, 2015.

Joni Eisen, president of the Club, called the meeting to order at 6:36 pm local time. She noted the presence of a quorum.

Ms. Eisen announced that Supervisor David Campos would present earlier in the meeting than was stated on the agenda. She then asked the membership if there were any other changes to the agenda. There being none, the revised agenda for the meeting was approved by acclamation.

Ms. Eisen introduced San Francisco District Attorney George Gascón, who discussed his incumbent candidacy with the Club.

The Club then considered some of the San Francisco propositions on the November ballot: The Club heard from:

Edwin Lindo, in favor of, and Jay Cheng, in opposition to, Proposition I, a suspension of market-rate development in the Mission.

Supervisor David Campos, in favor of, and Chris Bowman, in opposition to Proposition J, the legacy business historic fund.

Dale Carson, in favor of, and George Marshall, in opposition to, Proposition F, which restricts short-term residential rentals.

Jack Gallagher, in favor of, and J.R. Eppler, reading the opposition argument, without endorsement, for, Proposition A, the affordable housing bond.

Mayor Art Agnos and Jack Bair, in favor of, and Jon Gollinger, in opposition to, Proposition D, an increase in height limits for the Mission Rock development.

Larry Bush, in favor of, and Robert Boileau, reading the opposition argument, without endorsement, for, Proposition C, regulations on expenditure lobbyists.

Monisha Mustapha, reading the argument in favor of, without endorsement, for, and Lee Hepner, in opposition to, Proposition E, new requirements for public meetings.

Fernando Marti, in favor of, and Chris Bowman, in opposition to, Proposition K, regarding the City's surplus lands.

Ms. Eisen then made the following announcements:

The Club would host its Annual "Shop Local" Silent Auction & Party Saturday, September 19<sup>th</sup> from 5:00 to 8:00 pm at Dogpatch Saloon, 3<sup>rd</sup> Street at 22<sup>rd</sup> Street. Donations for the Auction and food for the potluck were solicited.

The Club's next meeting would take place on September 15 at 7:00 pm, at the Potrero Hill Neighborhood House. The Club would host an endorsement meeting for several San Francisco ballot initiatives and candidacies.

Ms. Eisen requested that Club members return their endorsement ballots.

There being no further business before the Club, Ms. Eisen adjourned the meeting at 9:05 pm.

Following the meeting, the Executive Committee of the Club counted the endorsement ballots that had been cast at the meeting. Following the count, the Club announced that it had made the following endorsements:

For Proposition A—General Obligation Bond Election–Affordable Housing, Yes.

For Proposition C—Expenditure Lobbyists Ordinance, Yes.

For Proposition D—Mission Rock, No Position.

For Proposition E—Requirements for Public Meetings of Local Policy Bodies, No.

For Proposition F—Restrictions on Short-Term Residential Rentals, Yes.

For Proposition I—Suspension of Market-Rate Development in the Mission District, Yes.

For Proposition J—Establishing the Legacy Business Historic Preservation Fund, Yes.

For Proposition K—Surplus City Property Ordinance, Yes.
